A pleasant result of this activity is that reports from everywhere tell me that the hams doing all this Public Service work have been having fun, too! Talk about a win-win situation! When you turn out at a ham radio Public Service event, not only are you doing a good thing, but you also get the rewards of doing good things with your friends, and building great memories too.

I can't see a downside anywhere—and there have been some opportunities for things to go wrong. One thing that impressed and pleasantly surprised me was the way everyone at a recent event hung together and made the most of a bad situation when the rain that had been threatening all day finally let loose with a vengeance.

I heard nary a complaint—everyone dug in and resisted Mother Nature's worst, almost defiantly, and after the deluge they all pitched in and dismantled the station in record time.

I think this may be one of those "survivor situations" where those who hung together in the face of peril built a stronger attachment to each other and to the group. The served agency noticed and expressed their admiration of our resolve.

Most remarkable is the fact that the "victims" keep coming back for more! They came to recent club meetings and to Field Day, and are making plans for "next time!" I guess a little bad weather doesn't scare these rugged

individuals off.

The event also exhibited another phenomenon which I think bodes well for Amateur Radio. While the event sponsors called on one club, the participants were members of neighboring clubs as well. They worked together like adults without rivalry or glory-seeking. The spirit of cooperation appears to be growing, and can only be a good thing for our future.

PEAKING OF cooperation and events, this year's Field Day activities show how well that concept works. Several clubs who participate in this publication joined forces with one another to put on a larger group effort, and it paid off, big-time.

The FD operation I attended was a joint effort of two clubs, and I have to say it was a very smooth-running operation. When I look at the logs and the rate graphs, it is obvious that the radios were manned and making QSOs the entire 24 hour period. Sunday is often a slow time at Field Day, but the rate graph shows a steady climb in QSO rate right up to the end.

Better, still, a number of hams were at their very first Field Day, and they got to get on the air. That will have a positive impact on their future Amateur Radio activities. Everyone was made to feel welcome, and there was more than enough to eat.

Setup and teardown went like clockwork, nobody went home mad or hungry—in fact nobody had any reason to be unhappy—and best of all, nobody got hurt!

Even Mother Nature cooperated (for a change) and we had beautiful, mild weather and an almost unbelievable lack of bugs.

The radios worked without a hitch, the antennas were first rate, and the computer logging was problem-free.

If it sounds like a charmed experience, it was. The one thing that made it so was the cooperation of everyone attending. We were all looking forward to the event, and everybody brought something to the table.

Some brought expensive radios, trusting that the rest of us wouldn't break them. Others brought antennas, and the wide variety proved to be a good thing as band conditions changed, allowing us to switch antennas to ones that



might work a little better given the rapidly changing band conditions.

Everybody got to eat and drink for free, and the menu selection was pretty good. This will be a memorable Field Day (for me, they *all* are!) for all of us, and I'd venture to guess that everybody went home looking forward to our next outings.

The good news for us, in this year of service, is that we won't have to wait too long! Many more activities are planned in the not-too-distant future by clubs throughout our region.

These activities will require volunteers to step up and do their part. Fortunately, our track record this year so far is so good that we all should have no trouble getting people to make a commitment to lend a helping hand.

When there is something in it for them, people are more willing to go out of their way to help. In our case, our local Amateur Radio Public Service activities offer something really special—the opportunity to help out in a big way with our friends and neighbors, while doing something we truly enjoy.






Monthly Breakfast

The Horseshoe Amateur Radio Club — A History

HE HORSESHOE Radio Club was founded in 1936 by Blair County radio amateurs, in response to the Johnstown flood occurring on March 17th of that year. On 11/2/1937 the Horseshoe Radio Club became affiliated with the ARRL..

George Hayes W8IBR was our first club president, holding office from inception of the club until amateur radio was silenced by the attack on Pearl Harbor on December 07. 1941. Fred Ambrose, W80ZF, was our first club member to become a silent key. He received his ticket and joined the club in 1938, and passed later that same year.

In late 1939 the club memorialized Fred by adopting his call for the club. After the war, In April 1946, Pennsylvania was re-assigned to the 3rd call district, and the club call changed to its current W3QZF, which today identifies one of our club repeaters.

The club initially met in a rented barn near Oak Avenue and Kittanning Point Road in Logan Township. Later the club met in downtown Altoona at 1211 11th Street, at the Fire Station on Burgoon Road and 6th Avenue, and currently meets at the Red Cross chapter house on 5th Avenue and 41st street.

In the early 1980s the club name was modified to become the Horseshoe Amateur Radio Club, to distinguish ourselves from the popular and growing CB radio craze. In 1996, the club incorporated and became the Horseshoe Amateur Radio Club. Incorporated. In 1998 the club obtained an IRS determination as a section 501(c)(3) tax

exempt organization.

The club currently holds call K3HRC in recognition of our original club name, and is used at club events and functions specific to our club.

Horseshoe maintains 2 VHF repeater systems and 1 UHF repeater located on Wopsononock Mountain just north of Altoona, PA.

The club meets the second Thursday of each month, at 7:00 PM at the Red Cross Chapter House at 4100 5th Avenue, Altoona. The club has a monthly breakfast meeting at King's Family Restaurant, 3000 6th Avenue, Altoona on the first Saturday, at 9:00 AM.

The club offers VE amateur radio exam testing quarterly in March, June, September, and December. See www.altoonahamexams.org for more information.



while sitting on the front porch of my home just outside Summerville, PA, I noticed some construction activity on the opposite side of the valley. My neighbor, Everett McLaughlin had permitted a small, open, Adirondack-type shelter to be built on his property by AYH, American Youth Hostels, as part of the Baker Trail.

The AYH folks stopped in, and gave us information on the trail, and information to aid hikers along the way. As it turns out we never realized that we lived right on the trail itself. I recall many solitary hikers, scout groups, families, and others hike the trail and



stay at the shelter. In the BC (Before Cellular) days, The McLaughlin, Snyder, and Duck families in the valley aided hikers with telephone use, water and directions. My neighbor, Sarah Duck kept a cherished logbook at her house for hikers to sign, from day 1 for fifty plus years. So you can say I am familiar with, and have a connection to the trail.

As some things tend to do in life, Hiking waned as an activity. The Pittsburgh AYH went defunct in the early 2000s, and the Trail was

left in limbo. The Rachel Carson Trails Conservancy adopted the trail. As a means to promote and generate interest in cleaning up, maintaining and using the Trail, they developed the concept of the Baker Trail Ultra Marathon (BT Ultra).

This is a 50 mile foot race. It is held annually on a rotating segment of the trail. The northern leg is from Cook Forest to Brookville, The middle leg, (which is being used this year), is from Summerville to Smicksburg, and the southern leg is from the Freeport end

"The Baker Trail is a 132-mile (212 kilometer) hiking and backpacking trail, following forest paths, old jeep trails and dirt roads through woods, farmlands, along rivers and creeks. The Baker Trail is one of the 18 state-designated hiking trails and is included on the trails map of Pennsylvania.

The Baker Trail was established in 1950 and named for the late Pittsburgh attorney Horace Forbes Baker... The trail originally extended from Aspinwall to Cook Forest State Park (133 miles). However, extensive development along the Allegheny River caused the Aspinwall-Freeport section to be abandoned.

In 1971, the trail was extended northward from Cook Forest Fire Tower to near the Allegheny National Forest, making the trail 132 miles long".

north to Smicksburg.

Runners can run individually, (yes they run fifty miles) or they can enter as a 5 person relay team each running 10 miles each. As of 06-25-2012, 58 individual runners and 5



relay teams have entered. The ages range from 17-71, (YES 71, He a Summerville native, and he is running solo.) The course follows woods trails and rural roadways.

I was contacted by Steve Mentzer, Race Director in 2005 in my capacity as Jefferson County ARES EC, asking for Communications Support. Steve Waltman, KB3FPN and I, with assistance of several other hams from the area, have assisted with the two northern legs in 2005, 2006, 2008 2009, and 2011.

Some years, we have "leapfrogged" each other from one check point to the next. Our communications support allows for accountability of the runners running through a wooded trail, and passing information for logistical support. As others have stepped forward, we have been able to provide communications with one of their logistics trucks whose driver is a non-ham. Also our leapfrogging has been a lot less hectic.

Several members of the race staff, impressed by the use of amateur radio, have obtained their licenses, and assist with other events in their home towns in communications. The Coordinator, Director, Logistics marshal and some of the aid station staff are hams, and they have 2 meter equipment set up for use.

There are 13 Aid stations between start and finish. The stations have a definite opening time and final closing time. These times range from 1.5 hours to upwards of 8 hours. A station will close early if all runners are checked in and accounted for. That station is then dismantled and supplies are moved to later opening stations by the 2 logistics truck crews. I would like to have one operator at each station if possible. In past years, we

utilized 144.97+ repeater for decent coverage. We may utilize Cowansville 146.505 +1 with 131.8 Tone.

Depending on lead time, APRS, among other modes may be deployed. In the past we have used a loose net format, however it has evolved into a very well-run format utilizing tactical identifiers (e.g. DIRECTOR, AID STATION 5, LOGISTICS ONE) as well as FCC call signs. Nothing is complicated, don't worry about errors, we are a forgiving group. The traffic volume isn't large at all.



Each of the aid stations have water, Gatorade, and snack food. The snack foods range from candy to granola to cookies to "potatoes with salt" They vary by location. These are geared toward the runners to provide carbohydrates and electrolytes along with fluid replacement. You are welcome to have some food, at these points. If you want other food, you will need to pack a lunch. Restaurants are few and far between in the race area. You are welcome to stay for the entire day, or work for a period of time. "As a thank-you, all volunteers receive a coveted Marshal t-shirt and the gratitude of hundreds of strangers!"

Consequently, it would be helpful to know who is attending and what your t-shirt size will be. A 2-meter mobile rig, either vehicle mounted or with battery supply and your favorite field antenna would be most helpful. Some sites

will have them there already. If you have APRS equipment, let me know. APRS usage will be determined at a later time.

A DTMF Alert For 2 Meters

HERE HAD BEEN some discussion in the Club about the lack of activity on the two meter repeaters. Many hams use only portable radios and have a problem with keeping the batteries charged when monitoring all day. Others have base radios and encounter some flack from family members about unwanted conversations and static that breaks the squelch. These are all valid points and contribute to a general lack of traffic on the repeaters.

Many Club members call each other and find that the called Ham is not on the air. I wanted to solve the problem by using a tone activated alert that would signal a ham when he or she was called. The alert also needed to work with existing radios, be easy to use and not cost a

lot. The solution was to use two DTMF decoder boards to trip a Sonolert buzzer when a tone was detected on the two meter repeater.

I started with two tone decoder boards which are kits from www.Ramseyelectronics.com. They use a 567 chip with a precision 10 turn resistor to tune to a single DTMF frequency. When using two of these boards it is possible to detect a single pair of tones generated by the DTMF (touch tone) keypad found on most two meter radio microphones and portables. It is then possible to set the two boards to detect, say, the number "2" for example. When a ham wants to call someone who has the DTMF Alert the number "2" is pressed and a DTMF pair of tones is transmitted. The called hams' radio feeds the received tone pair to the two DTM detector boards which both activate the Sonolert buzzer. A latching circuit holds the Sonolert on until a "reset" switch is pressed. Then the called Ham switches the two meter rig to normal operation and signs onto the repeater. At that time the calling Ham can initiate the conversation.

I'd found a Kenwood TM201A two meter transceiver on www.qth.com that sold for very little money. It had no CTCSS tone encoder so wouldn't work with "PL" tone encoded repeaters. I also had the Kenwood TS-520 speaker so the two made a nice looking pair. I used a Radio Shack plastic enclosure to house the two DTMF decoder boards and also the relay latch circuit. A second smaller plastic enclosure housed a two-position toggle switch that selects between alert and normal radio operation. The entire unit is powered from a 12-volt switching regulated power supply that sits beneath the table. In operation the Kenwood TM-201A operates in the low power position using a telescoping vertical whip antenna connected to a right

angle connector on the UHF RF connector at the back of the rig.

In practice the radio is tuned to the 147.00 MHz N3NIA repeater and placed in the alert operating position with the toggle switch. When a DTMF tone is received the Sonolert buzzes and someone in the house goes over and pushes the 'reset" button. That turns off the Sonolert and makes it ready to receive another DTMF tone. If I'm near the radio I then set the toggle switch to normal operation and sign on to the repeater. If we are away from home the Sonolert continues to buzz until I get home and reset it. It indicates that someone had tried to contact me.

The DTMF circuit is connected to the Kenwood radio through the external speaker jack. When the toggle switch is placed in normal operation it switches the audio from the DTMF decoder circuit to the big Kenwood speaker so normal audio is heard. The rest of the time the audio is connected to the input of the two decoder boards and the radio remains silent, even if static opens the squelch.

The system can be used with any repeater, VHF or UHF since the radio determines the repeater of choice. The two tone boards select a DTMF pair of tones so hams can select a individual DTMF "number" as their alert identifier. For example, I chose the number "2" so anyone accessing the N3NIA repeater and pushing the number 2 button on their radio would send the alert tone to my station. The Sonolert would buzz and I could then sign on to the repeater to chat. If another Ham used a different alert number the same sequence would alert him that someone was trying to contact him.

The goal is to help more hams monitor repeaters and respond to others who want to contact them. It doesn't address the problem of traveling hams coming through the area

who want to chat or need assistance. However, if the system encourages hams to use the repeaters more often that might help traveling hams find activity as well.

If you go to www.wikipedia.org and then search for DTMF tone frequencies the matrix will come up. The digit "2" is comprised of the high tone of 1336 Hz and the low tone of 697 Hz. The two TD-1 decoder boards are tuned to these frequencies using the 10 turn variable resistor. Their audio input is about the same as the volume for comfortable listening from the speaker and isn't critical for proper decoding. You can choose a digit for your system and then tune the TD-1 boards. When you think the boards are correctly tuned just key up your HT and use the DTMF pad to test.

I did run into an interesting problem when testing the system. The controller of the 147.00 and the 147.285 MHz repeaters here in Ridgway filter DTMF tones! The goal is not to retransmit these tones when used to activate auto-patch telephone calls. The system worked fine on simplex but the "2" digit was blocked by the repeater. This also presented a problem for some repeater users because the filter would block part of their voice and chop off their words. The N3NWL repeater had this problem and that went away when I reprogrammed its controller to disable the filter. The same problem was present on the N3NIA repeater but either we have different users or the filter had a different cutoff frequency. The chopping of words wasn't nearly as bad as on the N3NWL repeater but also went away when the controller was reprogrammed to disable the filter. Now the DTMF tones are present at the transmit output of both machines.

I usually hang out on the N3NIA repeater while Lee N3NWL hangs out on the N3NWL repeater. Both repeaters will work just fine with the DTMF Alert system. It remains for the

ham to decide what repeater he wants to use and then what digit his Alert system will monitor. Once these choices are made and the equipment is configured he is ready to begin monitoring. The system only works if other hams in the group know what repeater and digit he is using. That information can be uploaded to the Club web page for reference. That way, other hams will know how to reach him and also what digits are already in use.

DTMF tones have been used for decades in the telephone company as "touchtone" dialing that replaced rotary dial phones. The technology is tested, stable and easy to use.

Hopefully, this system will allow hams to monitor the repeaters while keeping peace in the house.



The Kenwood TM201A radio is attached to the Kenwood speaker with hook & loop fasteners. The plastic enclosures are also attached to the radio in this way. This makes a single unit that is easy to service and move for cleaning.




